

**MEMORANDUM OF DELEGATION**

**CONTRACT AUTHORITY – MAC OPERATING SYSTEM**

Warren Madden as Vice President for Business and Finance has delegated to me as Assistant Vice President for Business Services the authority to sign certain contracts and purchase orders. He has also authorized me to further delegate that authority.

Subject to the authority retained by the Board of Regents and the limitations on the Vice President for Business and Finance's authority as set forth in ISU's Contracting Authority Policy (Non-Employment Related), I authorize you to accept the Registered Apple Developer Agreement offered by Apple, Inc.


The account you establish through this process should be used only for activities that are on behalf of ISU. Accordingly, when you register with Apple you should elect to create an Apple ID rather than opting to use an existing ID that you may be using for activities that are not on behalf of ISU. Similarly, if you decide later to engage in activities that are not on behalf of ISU, you should establish a separate Apple ID for those activities.

You may use the account established through this process only to access Mac OS pre-release software unless you have received written approval from me to use your account for developing applications on Apple's iOS operating system. If you have received such approval, then you may use your account for both accessing Mac OS pre-release software and developing applications on Apple's iOS operating system that have been approved by the Mobile Application Review Committee. You may not use your account for developing Mac software or any other purpose without prior approval from the Mobile Application Review Committee.

You do not have authority to re-delegate this authority.

This delegation shall remain in effect so long as you are an employee of ISU.

## RADA ACKNOWLEDGEMENT – MAC PRE-RELEASE SOFTWARE

In order to have access to pre-release software for Mac Operating Systems, Apple will require you to register with it and accept the terms and conditions of a Registered Apple Developer Agreement (“RADA”). Apple may treat this RADA as a contract with you personally rather than as a contract with Iowa State University. Accordingly, it is important that you read and understand the RADA in its entirety before agreeing to accept its terms. If you previously registered with Apple in order to develop applications on Apple’s iOS operating system on behalf of ISU, you will not have to re-register but the terms of the RADA will still apply to your accessing of the Mac OS pre-release software. In addition, your access to the Mac OS pre-release software is subject to terms and conditions set forth in the Mac Developer Program License Agreement (“MDPLA”) between Iowa State University and Apple.

The following are a few of the terms and conditions of the RADA and MDPLA of which you should be aware:

- Your Apple ID and password to login cannot be shared with anyone. You are responsible for any activity that occurs on your account.
- You may use the Mac OS pre-release software for testing purposes only. You cannot use the software in a commercial operating environment or with important data. You should back up any data prior to using the software.
- You must abide by intellectual property laws and Apple’s notices, license information and restrictions, including the use of Apple’s trademarks and logos. You cannot decompile, reverse engineer, disassemble, or attempt to derive the source code of the Mac OS pre-release software.
- You should not provide any confidential information to Apple. Apple reserves the right to use any information provided by you in any manner Apple thinks is appropriate.
- You may not disclose or disseminate the Mac OS pre-release software or other Apple Confidential Information (as defined in the RADA) to anyone other than Iowa State University faculty and staff who have a need to have access to the Mac OS pre-release software and have signed an agreement prohibiting unauthorized use or disclosure of the Mac OS pre-release software or Apple Confidential Information.
- Apple provides no warranty that its Mac OS pre-release software will work or is free from viruses. Apple is not responsible for any damage that the software causes to equipment, data, or other software. You should consider this when deciding on which computer(s) you will download the software.
- Any lawsuit between Apple and you has to be filed in California.
- Apple may unilaterally limit or terminate your participation as a Registered Apple Developer at any time.


If you do not want to be contractually bound to the terms and conditions of the RADA and/or the above listed items, then you should not accept them. You will, however, be unable to access the pre-release software.

The account you establish through this process should be used only for activities that are on behalf of ISU. You may not use your account for developing Mac software or any other purpose without prior approval from the Mobile Application Review Committee.
